One craft brewery approved by Litchfield town, insurance by town clear- brewery ok so long as no alcohol served. Norbook applied to market, Katie running approval by BCA.

<u>Grants Update</u> Lauren completed and submitted application w Union Savings for playground. Bank makes decision June 3. Time frame to use proceeds if approved, one year. Kim and Lauren working on more grants.

## Signs Update etc:

Paul- signs in. Val put up chains between cement pillars. Paul would like to mark" NO PARKING IN FRONT OF GATE" on chain at the end of parking lot. Info going on Kiosk-copy of rules, contact information, Fundraiser flyer, calendar of events forthcoming.

<u>Non-Profit use of Field</u> Dick Sheldon's letter also refers to his view of no charge for noprofit use. Discussion of free use of park on case-by-case basis Katie suggests. A limit of 2-3 for season first come first serve also suggested and established local non-profits given preference.
