He passed around a detailed sketch of the proposal based on previous Eagle Scout projects. Kiosk would be one-sided with 2 plexi windows w magnets on bottom or hook eye. Suggested size should be under 8ft for stability. No estimate of costs yet. TBD. Will take basic plan and come up with estimate. Michael Lyn offers to assist w pricing- husband contractor with association with Iffland Lumber. Roland offers to do fundraising if necessary. Location for kiosk against steel fence by brick building. Val suggests overhang 3.5". Many uses for kiosk including posting rental contracts for field rental. Rental agreement is work in progress with attention to heavy vs light usage for example. Calendar, etc. posted here.
