Chairman Yarrish called the meeting to order at 7:08 p.m.

3. PUBLIC COMMENT

Mr. Brandon Merritt addressed the Commission with regard to 1218 Bantam Road. He is seeking a zoning permit for the single-family home in order to construct a master bedroom over the existing kitchen. Mr. Merritt noted that there would be no expansion of the footprint and the height would be 24'8". After an extensive review it was determined that the property is within the borough and Permit #7-21 was issued.
